# Sub: Engagement of Medical Practitioners and paramedical staff on Contract Basis in Jagjivan Ram Western Railway Hospital, Mumbai Central

In view of COVID-19 Pandemic ,Jagjivan Ram Hospital, Mumbai Central, Western Railway will be conducting Telephonic/ Whats app interview for filling- up the posts of Contract Medical Practitioners (GDMO / Specialist ) and Paramedical staff on full-time contract basis up to 30.09.21 to work in COVID Isolation wards of Jagjivan Ram Railway Hospital.

Candidates should have requisite academic qualification on the date of Interview. Those who are appearing at and/or awaiting results of final examination are not eligible. Academic and Technical Qualification must be from a recognized Institution/Board, otherwise candidature will be rejected. Candidates having higher qualification may also apply & indicate the details.

Since the posts are over and above the sanctioned strength of the cadre due to the exigencies on temporary measure up to 30.09.21 only no prescribed community distribution is applicable. However age relaxation of 5 years is applicable to SC/ST & 3 years to OBC categories against SC/ST & OBC vacancy respectively. Age will be reckoned as on the date of notification.

The vacancies indicated may vary, depending on fresh sanctions received, resignations being given by existing candidates, etc. There may be waitlisted/stand by candidates against the notified panel/select list who may be engaged as per the necessity.

Selected candidates will be required to work in COVID Isolation /Quarantine wards/Fever clinic of Jagjivan Ram railway Hospital. Hence a thorough knowledge about the risk involved has to be borne in mind.

If required their services may be utilized for general patients also.

No TA ,Pass/PTO /facility for accommodation / transport will be provided.

Retired Railway and Government employees up to the age of 65 years can also apply.

Post indicated herein may be kept unfilled at the discretion of administration.if Suitable candidates not found in specialist CMP Category then posts may be filled with GDMO CMP.

## Terms and condition

- 1. The selected Candidate will be engaged on contract terms for a period up to 30.09.21 from the date of Engagement subject to extension of validity of the Scheme for contractual appointment of CMP and paramedical staff by Railway Board. The engagement of the above candidate is a stop gap arrangement and will not count as service.
- 2. Engagement on Contract basis of the candidates will be subject to their being found suitable in order of merit by Selection Committee. The candidates found suitable against the requirement of vacancy in order of merit will be sent for Medical Test as per rules.
- 3. The decision of this office in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, selection, and allotment of posts to selected candidates will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection. Candidates who submits forged caste certificate for securing eligibility, shall be liable for rejection of his/her candidature for the particular post for which he/she has applied.
- 4. Contract Medical Practitioner and paramedical staff Candidate who enter into contract with the Railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as full time contract will not have any right in respect of considering of their period in regular selection through UPSC/ RRB nor will it confer any right for regularization or absorption .Candidates while applying should indicate past service rendered, if any including the period of contract put in by them on Indian Railway.
- 5. No other intimation will be given separately for Whatsapp / Telephonic Interview.
- 6. No private practice or any other employment will be permitted during the subsistence of the contract period.
- 7. No Objection Certificate (If working) from Current employer is required

The contract shall be liable to be terminated by giving two week's notice by either side without assigning any reason or if the contract practitioner is mentally/physically incapacitated. Contract will be also be terminated once need for COVID-19 pandemic is over.

Appearance in interview will not vest any right upon the candidate to be engaged and no reason will be sited or communication made in the event of candidate not selected

The Railway Administration reserves the right to deploy the candidate anywhere on the Division/Unit depending upon the exigency of service. Refusal otherwise on the part of the candidate shall be deemed to be misconduct
